A515 STATION ROAD, DRAYCOTT IN THE CLAY
(TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2017

WHEREAS the Staffordshire County Council ("the Council") being the highway authority for A515 Station Road in Draycott in the Clay is satisfied that the traffic on the said road in the Borough of East Staffordshire should be restricted by reason of works in connection with annual level crossing testing being executed or proposed to be executed therein.

NOW THEREFORE the Council in exercise of the powers conferred by the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other enabling powers hereby makes the following Order:-

1. Save as provided in Article 2 of this Order no person shall cause any vehicle to proceed in that length of A515 Station Road in Draycott in the Clay so much as passes by and is in the direct vicinity of the Level Crossing.
2. The provisions of Article 1 of this Order shall not apply to any vehicle being used for or in connection with the said works.
3. This Order shall come into operation on the 5 August 2017 and may be cited as the Staffordshire County Council A515 Station Road in Draycott in the Clay (Temporary Prohibition of Traffic) Order 2017.
4. That the following be the preferred alternative route for traffic affected by this Order namely:-

PREFERRED ALTERNATIVE ROUTE FOR TRAFFIC

A515 Station Road, A515 Lichfield Road, Unnamed Section Of A50 From A515 North To District Boundary, A50 J A515 Roundabout, A50 From J A515 Roundabout To J A515 W, A50 Through J A515 W, Unnamed Section Of A50 From Sudbury To District Boundary, A50 J A515 Join W, A50 From J A515 To J A518 W, Marston Lane, A50 From Derbyshire Boundary To Derby Road Roundabout A518, A50 J A518 Roundabout, A50 Bypass, A518 Derby Road, A518 Town Meadows Way, A518 Bridge Street, Old Knotty Way, B5017 Highwood Road, B5017 Uttoxeter Road, B5017 Birch Cross, B5017 Stubby Lane, Tobys Hill, New Row, A515 Main Road and vice versa.
